



PROVO GUN CLUB RULES

- Please read and understand the Club Rules and Regulations before you proceed to any of the ranges.
- Eye and ear protection must be worn while shooting or observing on any of the ranges.
- Be sure your firearm is safe to operate and know how to operate it safely. Use only the correct ammunition for your firearm. If you have any questions, please consult a gun club director.
- Firearms are to remain unloaded and pointed in a safe direction. Keep all actions open and finger off the trigger until it is your turn to fire. Shotguns are to be loaded only at the shooting station and only when it is your turn to fire.
- Never hand a loaded firearm to another person.
- Never load more than the required number of shells to complete the next shot. This number shall never exceed 2 shells. (Trap – 1 shell, Skeet – up to 2 shells, 5-stand – up to 2 shells, Sporting Clays – up to 2 shells).
- Only shotguns appropriate for clay target shooting are allowed on the ranges/fields. All shotguns must have a full-length stock. Assault type shotguns are prohibited.
- Only lead shot sizes 7 ½, 8, 8 ½, 9, steel shot and slugs are not allowed. Gauges larger than 12 are prohibited.
- Always check bore for obstruction after a misfire and before firing next round.
- A round of skeet, trap, or 5-stand consists of 25 targets. Sporting Clays may consist of either 50 or 100 targets. Additional targets requested may result in additional charges.
- Only shooters participating in a round of shooting are permitted on the fields. Skeet and Trap squads shall consist of no more than five shooters.
- Shooters under the age of 18 must be accompanied by an adult at all times while on the range.
- Children must not be left unattended.
- No inexperienced shooters are allowed on any ranges without prior instruction and an experienced shooter.
- Well behaved and friendly dogs may be allowed on Club property as long as the pet does not interfere with shooting games, participants and guests. No animals are permitted inside the club house. Pet owners must be responsible and clean up promptly after their pet soils the ground. Pets must never be left unattended.
- Only directors of Provo Gun Club or authorized members are permitted in the trap and skeet houses.
- Firing at tin cans, bottles, rocks, birds, animals, or any other object other than clay targets, or other authorized targets is strictly forbidden. Under no circumstances should Club improvements, props or barricades be used as target frames.
- If unsafe behavior is noticed, please make sure that a Provo Gun Club director is notified of such act immediately.
- No alcoholic beverages and/or illegal drugs may be consumed, used or brought onto Club property. Empty alcoholic beverage containers are also prohibited.
- Individuals displaying the effect of, or thought to be under the influence of drugs or alcohol will be prohibited from participating in any shooting activities and will be asked to leave the premises or may be escorted off the premises by law enforcement.

Provo Gun Club directors or authorized members are eligible to remove any shooter whose behavior is detrimental to the safe operation of any of the ranges. Violation of any of the Range Rules may lead to permanent barring from the Provo Gun Club. Please ask a director for clarification if you have any questions.

PROVO GUN CLUB ACKNOWLEDGEMENT OF RISK RELEASE & INDEMNITY AGREEMENT

1. I hereby acknowledge that I have voluntarily applied to enter on to and to engage in or to observe shooting and other activities at the Provo Gun Club. I further acknowledge and understand that "shooting and other activities" includes any and all activities of any kind whatsoever in which I engage or observe while at the Club, whether sponsored by the Provo Gun Club or not.

2. I ACKNOWLEDGE AND UNDERSTAND THAT SHOOTING ACTIVITIES involve both known and unanticipated risks which could result in damage or destruction of property and physical or emotional injury, including paralysis or death, of myself or of other persons. The risks include, but are not limited to being shot by myself or others, partial or total loss of eyesight or hearing, inhalation or other harmful contact with lead or other contaminants, and being struck by flying or falling objects. **I understand that such risks cannot be eliminated without compromising the essential qualities of shooting activities.**

3. I FURTHER ACKNOWLEDGE AND UNDERSTAND that the nature and condition of the Club facilities, premises and environment is such that both known and unanticipated hazards exist which create or contribute to both known and unanticipated risks inherent in entering on to the Club, in using Club facilities and in engaging in or observing any activities of any kind whatsoever while at the Club. I understand that such hazards and risks cannot be eliminated without compromising the essential qualities of the Club facilities, equipment, premises and environment. I acknowledge and understand that the Provo Gun Club has no duty to undertake first-aid or rescue operations or procedures in the event any such property damage or physical or emotional injury occurs, and that any such operations or procedures may result in compounded or increased damages or injuries.

4. I FURTHER ACKNOWLEDGE AND UNDERSTAND that the Provo Gun Club makes no warranty as to the design, manufacture, maintenance, condition or fitness for any particular purpose of any CLUB facilities or equipment, including, but not limited to: firearms, ammunition, eye/hearing protection, and first-aid supplies.

5. I EXPRESSLY AGREE TO ACCEPT AND ASSUME ANY AND ALL RISKS EXISTING ON THE CLUB AND IN ENTERING ON TO THE CLUB AND IN USING CLUB FACILITIES OR EQUIPMENT AND IN ENGAGING IN OR OBSERVING SHOOTING AND OTHER ACTIVITIES AT THE CLUB. I AGREE TO ABIDE BY ALL FEDERAL, STATE AND LOCAL LAWS AND CLUB RULES.

6. I FURTHER AGREE to assume all responsibility and liability for any negligent, reckless or criminal act or omission to act of my guests at the Club. I understand that "Guests" includes any person who is not a member of the Provo Gun Club who enters onto the Club, who uses the Club facilities or who engages in or observes shooting and other activities at the Club as a result of my express or implied invitation, permission or consent.

7. I hereby RELEASE AND FOREVER DISCHARGE AND HOLD HARMLESS the Provo Gun Club, its officers, directors, attorneys, agents, employees, contractors, volunteers, guests and affiliated individuals or organizations of the Provo Gun Club from and against any and all claims, demands, damages, expenses, causes of action, attachments of property, or liability of any kind whatsoever, that I, my next of kin, heirs, guardians, representatives or assigns may have for property damage, personal injury or death resulting from me or my guests entering on to the Club, from using Club facilities or equipment, or engaging in or observing shooting and other activities at the Club, even if such claims, demands, damages, expenses, causes of action, attachments of property, or liability result partially or wholly from any act or acts, even any negligent act or omission to act, including negligent or omitted first-aid or rescue operations or procedures, by the Provo Gun Club.

8. I hereby INDEMNIFY the Provo Gun Club, its officers, directors, attorneys, agents, employees, contractors, volunteers, guests and affiliated individuals or organizations of the Provo Gun Club, from and against any and all claims, demands, damages, expenses, causes of action, attachments of property, or liability of any kind whatsoever, that any party, including but not limited to me, my next of kin, heirs, guardians, representatives or assigns, any guest of mine, any next of kin, heirs, guardians, representatives or assigns of any guest of mine, or any other third party or entity claiming injuries or damages from the actions or inactions of me or any guest of mine for property damage, personal injury or death resulting from me or my guests entering on to the Club, from using Club facilities or equipment, or engaging in or observing shooting and other activities at the Club, even if such claims, demands, damages, expenses, causes of action, attachments of property, or liability result partially or wholly from any act or acts, even any negligent act or omission to act, including negligent or omitted first-aid or rescue operations or procedures, by the Provo Gun Club. This indemnification includes any expenses, including but not limited to attorney fees, incurred in the defense of any claims brought by or for any of the aforesaid persons, including third parties, as well as any damages awarded through litigation, mediation, ADR, or any other form of settlement in or out of court. It is my intent that no claim of any person or entity through me or my guests, or any claims of any person or entity against me or my guests shall ever cause the Provo Gun Club, to incur any expense of any kind whatsoever.

9. I UNDERSTAND that amateur or commercial still, video and/or motion picture photography may occur during my presence on the Club and that I may be incidentally included in such photography. Should I wish to be excluded from such photography, I understand that it is my responsibility to be aware of photographic activity and remove myself from the area or event being photographed. Absent such action on my part, I hereby grant the Provo Gun Club, its sponsors and beneficiaries, the right to use my photographic image in the promotion of the Provo Gun Club or shooting sports in general, in accordance with accepted journalistic practice.

10. I FURTHER ACKNOWLEDGE AND AGREE that this Agreement is intended to be as broad and inclusive as permitted by law, and that if any provision or portion is held to be invalid, contrary to law, void or otherwise unenforceable, then such portion does not void any other part of this agreement, and that the remaining provisions or portions shall continue and remain in full legal force and effect.

11. I FURTHER ACKNOWLEDGE AND AGREE that it is my understanding and intent that this Agreement, and any signed written amendments or modifications to it, shall remain in full force and effect from the date of execution and shall be applicable to each and every occasion that I or any guest enter on to the Club, use Club facilities or equipment or engage in or observe shooting and other activities at the Club.

I have carefully read this Agreement and I understand its contents. I acknowledge that no other inducement, assurance or guarantee has been made to me in consideration of my signing this Agreement, which I sign voluntarily and of my own free will. I further acknowledge and agree that this Agreement may be amended or modified only by a writing signed by me and by an authorized agent of the Provo Gun Club

I UNDERSTAND THAT BY MY SIGNATURE I AM GIVING UP SUBSTANTIAL RIGHTS AND THAT BY SIGNING THIS AGREEMENT I AGREE NOT TO SUE THE PROVO GUN CLUB. I ACKNOWLEDGE AND AGREE THAT THIS AGREEMENT SHALL BE INTERPRETED UNDER THE LAWS OF THE STATE OF UTAH AND THAT VENUE FOR ANY ACTION OR PROCEEDING SHALL BE IN UTAH, COUNTY, UTAH.
